Executive director report – Ms. Bre Lionetti

Good turnout with open house. Penny wars ongoing. So far have raised over \$1,700. Attendance is ok but some students out for longer periods of time. Independent studies has not been permitted during initial two weeks of school. FOSS kits have arrived and are being distributed to teachers.

Evaluation committee has met this week. Using program IAspire to provide walkthroughs and provide immediate evaluations. Ms. Lionetti has been doing observations in the classrooms.

Report card committee met this week. Agreements that many things should remain the same with the exception of transitioning 6th graders to letter grades.

Proposal has been made by some 4th grade parents for an overnight field trip, there are some questions that need to be considered about that. KPO has offered to assist with fund-raising for Astro Camp.

Parent Louis Rice will be bringing some state politicians to tour our school.

All grade levels have finished MAP testing with the exception of 1st grade who would like more time for children to get used to Chrome Books.

Enrollment report – Ms. Michele Asay

Enrollment is at 303. 70 total on the wait list. Wait list exhausted in 2nd, 3rd, 4th, 6th as of 8/30.

Financial Report- Mr. Jeffrey Ball

Got an update from Scott Warner this afternoon. We are in a strong financial position. Need to maintain diligence in managing cash flow. CPA has prepared a draft of the required annual audit which shows no concern. Revolving loan begins repayment today.

New air conditioning is working, payment has been made.

Middle School Campus Search Report - Ms. Charlene Reed

Submitting a Memorandum of Understanding with Le Port to begin discussions to sublease a property that they are currently leasing from Fountain Valley School District.
